

MINUTES OF THE WORKING SESSION OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF AUDUBON PARK, IN THE COUNTY OF CAMDEN, NEW JERSEY, HELD SEPTEMBER 17, 2012 IN THE MUNICIPAL BUILDING AT 7:00 PM.

A regular meeting of the Mayor and Borough Council of the Borough of Audubon Park was convened in the Municipal Building, 20 Road C, 2nd Floor, Audubon Park, NJ on Monday, September 17, 2012, at 7:00 PM.
