## ORDINANCE OF THE BOROUGH OF AUDUBON PARK, COUNTY OF CAMDEN AND STATE OF NEW JERSEY REPEALING ORDINANCE #1, ENTITLED "AN ORDINANCE TO CREATE A LOCAL BOARD OF HEALTH, IN THE BOROUGH OF AUDUBON PARK"

- WHEREAS, the Borough of Audubon Park ("Borough") is a municipal entity organized and existing under the laws of the State of New Jersey and located in Camden County; and
- WHEREAS, the local Board of Health was previously created by Ordinance #1 to perform the duties imposed and carry into effect the powers conferred upon the local Board of Health by the laws of the State of New Jersey; and
- WHEREAS, the Governing Body has deemed it necessary and in the best interest of the public health, safety and welfare of the residents to update the provisions pertaining to the establishment, membership and powers of the local Board of Health; and
- WHEREAS, pursuant to N.J.S.A. 40:48-2, the Governing Body is authorized to enact and amend ordinances as deemed necessary for the preservation of the public health, safety and welfare and as may be necessary to carry into effect the powers and duties conferred and imposed upon the Borough by law; and
- WHEREAS, the Governing Body believes that it would be beneficial to the residents of the Borough to repeal Ordinance #1 and replace the same with a new ordinance outlining the establishment, membership and powers of the local Board of Health.
- **NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Audubon Park, County of Camden, and State of New Jersey, as follows:
- **SECTION 1:** Ordinance #1, which provides for the establishment of the Local Board of Health within the Borough of Audubon Park, County of Camden, and State of New Jersey, is hereby repealed in its entirety.
- **SECTION 2:** All references in Borough ordinances to Ordinance #1 are hereby repealed and removed in their entirety.
- **SECTION 3:** Except as set forth in Sections 1 and 2 above, the balance of the Borough's ordinances shall not be affected by this Ordinance.
- **SECTION 4:** All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.
- **SECTION 5:** If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of

judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

**SECTION 6:** This Ordinance shall take effect upon passage and publication according to law.
